Meeting Minutes from the November 29, 2016 Board of Directors Meeting

Meeting was called to order by Jeb (President) at 8pm.

- 1. We welcomed two new Board Members Dan and Jacklynn.
- 2. Approved meeting minutes from both the October 11, 2016 Board of Directors Meeting as well as from the November 1, 2016 Annual General Meeting. Will now be added to the website.
- 3. Updates
 - Fee Collection 575 homeowners have paid their 2016 fees with 64 homes owing.
 - Banking current bank balance is \$191,077. Please see 2016 Budget & Actuals to follow.
 - Fence the fence rails have been purchased. The contractor is now waiting for better weather to complete the repairs to the stucco fence along WW Drive at 700 WW Place.
 - Holiday Décor the decision was made to add solar powered lights to each of the three entrance features to light-up the planters that were already added to each. A decision was also made to further investigate the addition of wreaths (not lighted) to the light poles at the 85th Street community entrance. Update: lights, but not wreaths added.
- 4. Banking Changes let the minutes reflect that only the following directors are to have signing authority (remove all others) and that the mailing address should be changed to the following.
 - Only two current directors should have signing authority Axel and Sean.
 - Please remove any others that may be listed as having signing authority.
 - These two additional directors should be given signing authority Jeb and Ali.
