Call to Order and Quorum:

Fence Maintenance (A. Berry and T. Dickey)

Andrew and Tom have checked the community fences for any painting and/or maintenance requirements, including the removal of any graffiti. This is ongoing, and the Board will estimate requirements for 2020. Some areas along Bow Trail still need repair due to the construction work, and Tom is waiting for replies from the City of Calgary on that issue.

COVID Update

All planned community events including the spring cleanup and garage sales have been cancelled due to government COVID-19 regulations and social distancing measures.

Annual General Meeting (AGM)

With the cancellation of the 2020 AGM due to the COVID-19 virus and meeting restrictions put in place by government, a new date and venue for the AGM will be determined when appropriate. A notice of the meeting will be sent out at that time.

Landscaping

Foothills Landscaping have started the spring cleanup in common areas. It was determined that some new additional planters may be appropriate. Tom has asked for pricing from Foothills on various sizes of planters. Once this is received, the Board will decide on the size and number of planters, and where they will be located around the community.

Tom is working with the City on a landscaping agreement which will summarize responsibilities.

Tree pruning along the streets is the responsibility of the City of Calgary and the Residents' Association is not allowed to do any maintenance of trees. If residents notice any trees that require maintenance, including safety hazards or removal of branches, **please phone 311** and report this to the City. This is encouraged, as the more calls made, the better the chance of action by the City.

Archiving

Brenda received a box of old files and reports from the contractor employed by the SRA in prior years. She will review the information received and forward to Shelley, who will investigate options to store this information for future reference and access for current and future Boards, along with files from the last few years under the current Board.
