Fence Maintenance (T. Dickey)

Some areas along Bow Trail still need repair due to the construction work, and Tom is working with the City of Calgary on that issue.

Annual General Meeting (AGM)

With the postponement of the 2020 AGM due to the COVID-19 virus and meeting restrictions put in place by government, the Board discussed holding a "virtual" meeting, but this was deemed to be too difficult and impractical to set up. A further notice will be sent out to all residents on the AGM.

Landscaping

The Board decided to acquire three additional planters, which will be the same size as the current planters. Locations for the new planters have been determined and Foothills will install them as soon as possible. The Board will check on the condition of the trees, determine any potential pruning requests to the City, and any planters located too close to trees. Some pruning has been done by the City, but the only pruning they will do is on trees blocking roadways, walkways or sidewalks where visibility or accessibility is impacted.

Archiving

Shelley is exploring digital file storage options of historical SRA information for future reference and access by the Board.

Website

Shelley is in the process of updating the payment page of the Springside website which will involve work by an outside consultant. The Board has approved up to \$250 for this purpose.
