Fence Maintenance (T. Dickey)

Tom will develop a maintenance plan budget so that the fences can be consistently maintained year over year. The priority will be Wentworth Drive and any resealing required. Tom will meet with the selected fence contractor to discuss costs and path forward.

Tom stated that we need to decide on how to proceed with fence maintenance each year. We should either decide on doing several panels each year, or a specific amount each year. Options were also discussed on whether to do both sides of panels, or just the outside. Since the inside is the responsibility of the homeowner where appropriate, we need to decide how this will be handled, as far as payment and any billings. The first priority should be the "outside" fencing along Bow Trail and 85th Street

Landscaping (T. Dickey, G. Moriarty)

- 1. Bids will be requested for our landscaping contract covering the 1-2 years subsequent to 2021. The RFP was reviewed and some changes were made. If required, a "walk-thru" can be done with the contractors between August 5 –10. Proposals are due by August 30.
- 2. A new large pot has been installed by Foothills Landscaping along 77th Avenue.
- 3. New mulch has been installed at various locations around Springside by Foothills Landscaping.
- 4. 10 junipers have been planted along the path opposite St Joan of Arc school.
- 5. A community notice board will be setup for any notices and/or local information. Tom is waiting for the notice board to be built and a location will be decided.

Approval and budgets of the above landscaping items completed was made at the June 3 directors meeting.
