#### **Call to Order and Quorum:**

Directors in attendance constituted quorum (6/7 Directors). Tom Dickey chaired the meeting and Dave Mallabon acted as minute-taker.

#### Approval of May 31, 2022 Board Meeting Minutes (D. Mallabon)

The meeting minutes from the May 31 Board meeting were distributed to members via e-mail following the meeting. For the July 6 meeting, all comments were incorporated into the minutes and agreed to.

#### Treasurer's Report (B. Merz)

The May and June Financial Statements were presented by Brenda. The main changes for both months were: the payment of annual fees by 9 homeowners (10 remaining), late payment fees of \$700 charged to homeowners, \$702 paid to AGM scrutineer, \$296 for online payment charges, \$1,018 to DBH Law for Restrictive Covenants review as they pertain to fences and walls (value includes a \$900 discount) and \$7,230 for the first payment of the landscaping contract.

It was agreed by the Board that if the remaining annual fees plus late charges are not paid by August 15, they will be sent to our lawyers for collection.

Tom met with the selected fence contractor and work has been delayed due to the inability for him to find painters and other staff. Tom has talked to another contractor and he is reviewing the work and will prepare a quote for the work.

# Landscaping (G. Moriarty)

Gwen has received a quote from Foothills Landscaping for additional work (mulch and shrubs) for along the path from 77<sup>th</sup> Street to the school. There was a discussion on this, and Tom thought this should be the responsibility of the City. There was a discussion on the overall responsibilities of both Springside and the City regarding the landscaping and other green spaces.

Brenda and Shelley will compose a letter to the City on our various issues with landscaping, pathways, trees, grass cutting, garbage cans, speed control on Wentworth Drive and signage on 85<sup>th</sup> Street.

#### **New Business**

The community cleanup day was held on Sunday, June 19 from noon until 2:00 PM. Apparently, the subdivision was in fairly good condition, and the event went well and a number of volunteers turned up to assist with the cleanup.
