Any outstanding fee amounts still owing by August 15 will be sent to legal for collection. June activity includes income of \$233 for interest income and \$110 for admin and payment fees. June also included landscaping costs of \$14,810 for the May contract fees and the planting of the annuals in the pots.

## **Landscaping** (G. Moriarty)

The overall maintenance of Springside could be a little better. Tom and Gwen will meet with Foothills Landscaping to discuss and review this. Apparently, there has been changes in Foothills management. Also, we will have to start thinking about whether to use Foothills for an optional 3<sup>rd</sup> year, or go out for quotes.

## **New Business**

Another meeting will be set up with neighbouring communities, and especially including the West Springs Cougar Ridge Community Association, to review and discuss city engagement on various maintenance issues. Date to be determined in the future. Tom has e-mailed WSCR about a meeting, but has not heard back from them yet.

Colin is reviewing credit card fees on homeowners' payments on what options may be available, as far as invoicing payments, etc.
