Call to Order and Quorum:

Fence Maintenance (T. Dickey/B. Merz)

It was decided that we would proceed with a trial pilot with the homeowners in the houses that back onto the ravine along 600 Wentworth Place SW concerning fence replacement. A metal fence is being suggested similar to the one installed on 700 Wentworth Place SW. An e-mail will be sent to these homeowners explaining the pilot project, as well as setting up a Zoom meeting with them to answer any questions. A unanimous agreement will be required from all homeowners to proceed with the fencing, as well as prepayment to proceed. This only covers the fence along the ravine at the back of each property, and not any other fencing on the properties.

Landscaping (G. Moriarty)

The Board will send out requests for quotations to three companies for the landscaping for the next two years. We will contact Foothills, Landform and one other for quotes.

New Business

Another meeting will be set up with neighbouring communities, including the West Springs Cougar Ridge Community Association, to review and discuss city engagement on various maintenance issues. Date to be determined. Tom has e-mailed WSCR about a meeting, and has received a positive reaction. Richard Pootmans, our local councillor, is holding an Open House in early October which Tom and Colin plan to attend.

Colin is reviewing payment options as far as invoicing, payments, etc. He has reviewed several options including card types, payment contracts, Interac and e-transfers. He will continue to review the options and make a recommendation on a path forward.
